ELIGIBILITY CRITERIA

Eligible Bidder is a Bidder who:

- Ñ Is registered with Tax Authorities (NTN, GSTN, PSTN) as per relevant laws in Pakistan (if applicable);
 - Ñ Provides audited financial statements / copies of work orders / contracts signed in FY 2015-16 or 2014-15 depicting sound financial strength [minimum Rs.3 million in a financial year];
 - Ñ Has relevant experience supported by at least five copies of contracts / work orders/ MOUs, etc.
 - Ñ Does not apply in the capacity of Joint Venture;
 - Ñ Has submitted bid security of Rs.100,000/- in form of a Pay Order/CDR/Demand Draft in favor of Punjab Education Foundation as per bid security clause of Punjab Procurement Rules 2014 (amended till date) which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price of procurement;
 - Ñ Has purchased Bidding Document from the office of Deputy Director (Procurement) only, on cash payment of Rs. 500/- (nonrefundable).
 - Ñ Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or autonomous body or Private Sector Organization anywhere in Pakistan.
- .Note:** Verifiable documentary proof for all above requirements is mandatory.

- A pre-bid meeting will be conducted at **11:00 am** on **August 1, 2017** in order to clarify the queries of the prospective bidder(s).
- The proposals must be submitted in the office of Deputy Director Procurement till **August 7, 2017** before **12:00 pm** at the below mentioned address.
- Technical Proposals will be opened publically by a Committee at **12:30 pm** on the last day of submission of proposals in the presence of Bidders or their authorized representatives who wish to witness the tender opening. After the Technical evaluation, Financial Proposal of only technically qualified bidders shall be opened on a date and time to be announced subsequently.
