ELIGIBILITY CRITERIA

Eligible Bidder is a Bidder who:

1. Is an active tax payer of National Tax (NTN) and General Sales Tax (GST)/ Punjab Sales Tax (PST) (whichever is applicable);
2. Must be registered with Government of Pakistan under the relevant Laws and with relevant Authority.
3. Has submitted Rs. 36,000/- as the bid security in form of a Pay Order/CDR/Demand Draft in favor of Punjab Education Foundation as per bid security Rule of PPRA Rules 2014 (Amended till date) which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price of procurement.

5. Provides audited financial statements / copies of work orders / contracts / MOUs etc. signed in FY 2015-16 or 2016-17 depicting sound financial strength: [minimum Rs.5 million in a financial year];
6. Will provide the complete detail of 10 of its clients along with Client name, contact person, phone number, addresses and scope of work with respective client.

8. Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous Body or Private Sector Organization anywhere in Pakistan
