- **4.** Has experience of providing same kind of services for at least 3 years supported by documentary proof like copies work orders/ contracts/ MOUs, etc.;
- **5.** Has experience of providing same kind of services supported by documentary proof like copies of at least five work orders/ contracts/ MOUs, etc.;
- **6.** Does not apply in the capacity of Joint Venture;
- 7. Has submitted Rs.20,000/- as the bid security in form of a PO/CDR/DD/BC in favor of Punjab Education Foundation as per bid security Rule of Punjab Procurement Rules 2014 (Amended till date) which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the price of procurement estimated by the Procuring Agency.
- **8.** Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous Body or Private Sector Organization anywhere in Pakistan.
- **9.** Has purchased Tender Document from the office of undersigned upon a cash payment of Rs.500/-(nonrefundable).
