“TENDER FOR PRINTED PVC CARDS FOR PEF EDUCATION VOUCHER SCHEME”

Punjab Education Foundation (PEF) is an autonomous organization, established under the auspices of the Government of the Punjab, committed to the promotion of Quality Education through Public Private Partnership.

Sealed Technical and Financial Proposals in accordance with Punjab Procurement Rules-2014 (Amended till date of advertisement of this ITB notice), Clause 38 (2) (a), “Single Stage - Two Envelope Bidding Procedure” are invited from reputed and registered bidders for the procurement of printed PVC cards. Quantity of cards required is as under:

Note: Detailed specifications of the cards are given in the relevant bidding document.

ELIGIBILITY CRITERIA

Eligible Bidder is a Bidder who:

1. Is registered with Tax Authorities for NTN and GSTN/ PSTN (whichever is applicable);
2. Provides copies of audited financial statements/ work orders/ contracts/ MOUs, etc. for the FY 2015-16 or 2016-17 depicting sound financial strength (minimum Rs.5 million in a Financial year);
3. Has experience of providing related items supported by documentary proof like copies of three (03) work orders/ contracts/ MOUs/ satisfactory completion certificates, etc. of the same;
4. Does not apply in the capacity of joint venture;
5. Has submitted Rs.50,000/- as the bid security in form of a PO/CDR/DD/BC in favor of Punjab Education Foundation as per bid security Rule of Punjab Procurement Rules 20 14 (Amended till date of advertisement of the relevant ITB notice) which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the price of procurement estimated by the Procuring Agency;
6. Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous Body or Private Sector Organization anywhere in Pakistan;
7. Has purchased Bidding Document from the office of Deputy Director (Procurement) only, on cash payment of Rs. 500/- (nonrefundable).

Note: Verifiable documentary proof for all above requirements is mandatory, noncompliance shall lead to disqualification. Noncompliance of any term or condition mentioned in the relevant ITB Notice or Bidding Document shall also lead to disqualification.

TERMS AND CONDITIONS

1. A pre-bid meeting will be conducted at **11:00 am** on **September 17, 2018** in order to clarify the queries of the prospective bidder(s).
2. The proposals must be submitted in the office of Deputy Director Procurement till **September 24, 2018** before **03:00 pm** at the below mentioned address.
3. Technical Proposals will be opened publically by a Committee at **03:30 pm** on the last day of submission of proposals in the presence of Bidders or their authorized representatives who wish to witness the bid opening. After the Technical evaluation, Financial Proposals of only technically qualified bidders shall be opened on a date and time to be announced subsequently.
4. Bidding Document would be immediately available for purchase after the publication of this notice.
5. Punjab Education Foundation reserves the right to reject all the proposals at any time prior to the acceptance of a bid or proposal.
