Late bids shall not be accepted.
7. Bids will be opened in the presence of bidders' representatives who choose to attend at **11:30 a.m on same day** in the office of Punjab Education Foundation at 52-L Gulberg – III near Kalma Chowk, Lahore, Pakistan, on the same date of bid submission.
