Sealed bids must be delivered to Dak Section of Punjab Education Foundation located at 52-L, Gulberg – III near Kalma Chowk, Lahore till **11:00 a.m.** on **January 27, 2022** and must be accompanied by **bid security** in form of CDR, Pay Order, Demand Draft, or Banker's Cheque from a Scheduled Bank of Pakistan. Late bids shall not be accepted.
8. **Bids will be opened in the presence of bidders' representatives who choose to attend at 11:30 a.m. in the office of Punjab Education Foundation at 52 – L, Gulberg – III near Kalma Chowk, Lahore, on the same date of bid submission.**
