

INVITATION TO BID NOTICE FOR PROCUREMENT OF VIDEO CONFERENCE SYSTEM

1. Sealed Technical and Financial Proposals in accordance with Punjab Procurement Rules-2014 (Amended till date of advertisement of this ITB Notice), Clause 38 (2) (a), “Single Stage - Two Envelopes Bidding Procedure” are invited from registered bidders. Bidders shall submit their proposals in line with Bidding Document. Details of goods required are as under:

Sealed Bids must be delivered to Dak Section of Punjab Education Foundation located at 52-L, Gulberg – III near Kalma Chowk, Lahore till **11:00 a.m. on March 28, 2022** and must be accompanied by a **Bid Security as mentioned in above table** which is 2% of the price of procurement estimated by PEF in the form of CDR, Pay Order, Demand Draft, or Banker’s Cheque from a Scheduled Bank of Pakistan. Late bids shall not be accepted.
6. Bids will be opened in the presence of representatives of bidders who choose to attend at **11:30 a.m.** in the office of Punjab Education Foundation at **52 – L, Gulberg – III near Kalma Chowk, Lahore**, on the date of tender submission.
