- Is an active tax payer of National Tax (NTN) and General Sales Tax (GST)/ Punjab Sales Tax (PST) (if applicable);
- Provides audited financial statements or copies of work orders / contracts of FY 2015-16 or 2014-15 depicting sound financial strength (minimum Rs. 3 million in a financial year)
- Has submitted bid security amounting to Rs. 60,000 /- in form of a Pay Order / CDR / Demand Draft in favor of Punjab Education Foundation as per bid security clause of Punjab Procurement Rules-2014 (amended till date), which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price of procurement;
- Certificate of authorized dealership or distribution must be provided.
- Provides copies of five (05) work orders/ contracts showing supply of related items.
- Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous Body or Private Sector Organization anywhere in Pakistan.
- Has purchased Bidding Document from the office of undersigned upon a formal request and cash payment of Rs. 500/- (nonrefundable).

**Note:** Verifiable documentary proof for all above requirements is mandatory, noncompliance will lead to disqualification.

4. After the Technical evaluation, Financial Proposals of only technically qualified companies shall be opened on a date/time to be announced subsequently.

6. Incomplete proposals shall be rejected. Late bid will not be accepted.
