ELIGIBILITY CRITERIA

Eligible Bidder is a Bidder who:

- Registered with Tax Authorities (NTN, STRN, PNTN) as per relevant laws in Pakistan. (Whichever is applicable)
- Provides audited financial statements or copies of work orders / contracts for related items of FY 2015-16 or 2014-15 depicting sound financial strength (minimum Rs. 3 million in a financial year)
- Has submitted bid security mentioned in Bid Security Clause of this document in form of a Pay Order/CDR/Demand Draft in favor of Punjab Education Foundation as per bid security clause of Punjab Procurement Rules 2014 (amended till date) which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price of procurement;
- Provides copies of five (05) work orders/ contracts showing supply of related items against each lot applied;
- Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous Body or Private Sector Organization anywhere in Pakistan.
- Provides verifiable authorized certificates of distribution/ dealership for Lot- A only.
- Has purchased Bidding Document from the office of undersigned upon a formal request and cash payment of Rs. 500/- (nonrefundable).

Note: Verifiable documentary proof for all above requirements is mandatory, noncompliance will lead to disqualification.

2. The proposals must reach the office of the under signed on or before **6th April, 2017** till 12:00 pm.
3. Technical Proposals will be opened on the same day at 12:30 p.m. in presence of Bidders or their authorized representatives who wish to witness the tender opening.
4. After the Technical evaluation, Financial Proposals of only technically qualified companies shall be opened on a date/time to be announced subsequently.
5. Incomplete proposals shall be rejected. Late bid will not be accepted.
6. PEF reserves the right to reject all the proposals, submitted in response to this tender notice prior to acceptance.
