Eligible Bidder is a Bidder who:

- N Is an active tax payer of National Tax (NTN) and General Sales Tax (GST)/ Punjab Sales Tax (PST) (if applicable;
- N Provides audited financial statements / copies of work orders / contracts signed in FY 2015-16 or 2014-15 depicting sound financial strength:
- Ñ [For New Toners: minimum Rs.3 million in a financial year];
- Ñ [For Toner refilling/recycling: minimum Rs.2 million in a financial year];
- N Has relevant experience of last three years supported by copies of contracts / work orders
- N Provides authorization certificate of distribution/ dealership or authorization certificate of reseller via dealer shall be provided) for only Lot (A).
- N Does not apply in the capacity of Joint Venture;
- N Has submitted bid security mentioned in above table in form of a Pay Order/CDR/Demand Draft in favor of Punjab Education Foundation as per bid security clause of Punjab Procurement Rules 2014 (amended till date) which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price of procurement;
- N Has purchased Bidding Document from the office of Deputy Director (Procurement) only, on cash payment of Rs. 500/- (nonrefundable).
- N Bidder must have the capacity to provide required toners within 24 hours.
