Eligible Bidder is a Bidder who:

- Is an active tax payer of National Tax (NTN) and General Sales Tax (GST)/ Punjab Sales Tax (PST) (if applicable);
- Provides audited financial statements / copies of work orders / contracts signed in FY - 2014-15 or 2015-16 depicting sound financial strength (minimum Rs.5 million turnover in a financial year)
- Has experience of providing furniture items supported by documentary proof like copies of at least five work orders/ contracts;
- Has submitted bid security amounting to Rs. 35,000/- in form of a Pay Order/CDR/Demand Draft in favor of Punjab Education Foundation as per bid security clause of Punjab Procurement Rules 2014 (amended till date) which states that a procuring agency may require the bidders to furnish the bid security not exceeding five per cent of the estimated price of procurement;
- Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous Body or Private Sector Organization anywhere in Pakistan
- Has purchased Tender Document from the office of undersigned upon a formal request and cash payment of Rs. 500/- (nonrefundable).

Note: Verifiable documentary proof for all above requirements is mandatory, noncompliance will lead to disqualification.
